#### Most important symptoms and effects, both acute and delayed:

May cause respiratory tract irritation. Nausea, Headache, Shortness of breath. Irritation- all routes of exposure. May cause gastrointestinal irritation with nausea, vomiting and diarrhea. May cause respiratory irritation;

### SECTION 5 : Firefighting measures

#### Extinguishing media

**Suitable extinguishing agents:** Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition. Use water, dry chemical, chemical foam, carbon dioxide, or alcohol-resistant foam.

#### Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors.

#### Advice for firefighters:

**Protective equipment:** Use NIOSH-approved respiratory protection/breathing apparatus.

**Additional information (precautions):** Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. #### Methods and material for containment and cleaning up:

Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
