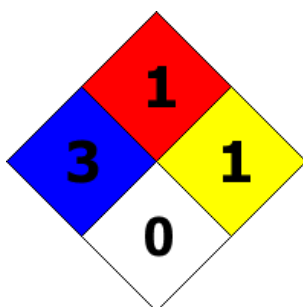

Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Seek medical attention if irritation persists or if concerned.

### After swallowing:

## SECTION 5: Firefighting measures

### Extinguishing media

#### Suitable extinguishing agents:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. ## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Transfer to a disposal or recovery container. Use spark-proof tools and explosion-proof equipment. Use respiratory protective device against the effects of fumes/dust/aerosol. Ensure adequate ventilation. Keep away from ignition sources. Protect from heat. Stop the spill, if possible. Contain spilled material by diking or using inert absorbent.

### Methods and material for containment and cleaning up:

Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter).

## Barium Hydroxide

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

### Conditions for safe storage, including any incompatibilities:

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Keep container tightly sealed. Store with like hazards.

### Appropriate Engineering controls:

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
