### SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

**Composition:** 500 mM HEPES [4-(2-Hydroxyethyl) piperazine-1-ethanesulfonic acid], pH 7.6 ± 0.15. Prepared in 18.2 megohms water, pH adjusted with potassium hydroxide (KOH) to pH 7.6 ± 0.15, and filtered through 0.22-micron filter.

### SECTION 4 - FIRST-AID MEASURES

#### **4.1 Description of first aid measures**
